#### *Rules and procedures for participation*

1. *The association "The streets of the Mediterranean" organized a photo exhibition within that Festival, titled "Mare Nostrum, poesia, colori, gente del Mediterraneo".*

*The exhibition, open to all photographers who want to exhibit their works, under the conditions of this Regulation, intends to promote through the images on display, the beauty of the Mediterranean, its territory, the people who live it and its sea.*

2. *The selected works at the sole judgment of the organization, on the basis of technical quality and the relevance to the theme, will be printed and displayed, from 1 to 30 September 2017 will be projected in video format.*

3. *Each author wishing to participate, please send your photos in JPG format to the e-mail marenostrumsicily@gmail.com, no later than midnight on 31 May 2017 accompanied by a copy of the registration form downloadable from the fb page facebook.com/marenostrumfestival or from www.festivalmarenostrum.com duly completed and signed by the exhibitor. Any links from which to download the power works should always be sent by e-mail at the above address.*

4. *photos must be in jpg format, sRGB color profile, and the 3000 pixel size on the long side, at a resolution of 300 dpi. The file name must be to work. (Eg. Tramonto.jpg) will indicate that the name of the work is "sunset").*

5 *Photos must be related to the theme of the exhibition.*

6 *Photos possibly will not contain any signature or other distinctive element which brings to the author. The exhibitor's name and the title of the work will be affixed on a label detached from the work.*

7. *Photos printed, and the files will remain the organization for any other exhibitions and cultural events at no cost.*

8. *by sending photos, the exhibitor implicitly declares to have read this Regulation and authorizes the organization to print and exhibit the submitted works, also in further dates and unbeknownst Exhibitor.*

9. *Participation is totally free and without any cost. The costs of printing and preparation will be borne by the organization.*

10. *The intellectual property of the works remains exclusive exhibitor who can use them at will ( participation in other exhibitions and so on.)*

*11. The exhibitor, by signing this Regulation, declares, under its responsibility, to be sent to the author of the work and to be in possession of all permits to the publication of images depicting people. The organization accepts no liability arising from the content or the ownership of the rights to the works on display.*
